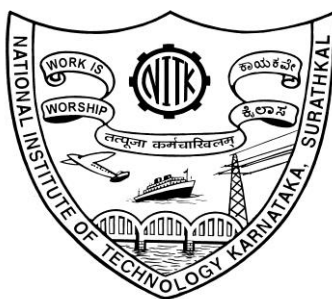

All components of expenditure to arrive at Bangalore need to be explicitly specified.
