#### **Instructions to the candidates:**

All the candidates,

- a) Who had SECURED the seat allotted during JoSAA-2020 rounds but did not report during 16<sup>th</sup> to 21<sup>st</sup> November, 2020 at NITK Surathkal
- b) Who have retained/upgraded their seat of JoSAA rounds in CSAB Special rounds and accepted a seat at NITK Surathkal
- c) Who have been allotted a new seat at NITK Surathkal and confirmed the same in CSAB Special rounds I and II.

are required to complete the admission process at NITK Surathkal during 26<sup>th</sup> November, 2020 to 1<sup>st</sup> December 2020.

After the declaration of CSAB-2020 special round-II results, the candidates who have been allotted a seat freshly at NITK Surathkal are required to upload documents, pay seat acceptance fee and go through document verification as usual as per the CSAB schedule in the CSAB portal. This step is mandatory for such candidates, to be eligible for admission at NITK Surathkal.

In view of the COVID-19 Pandemic, the admission process will be conducted in online mode. All the above categories of candidates **are required to report online at NITK during 26<sup>th</sup> November 2020-1<sup>st</sup> December 2020 for completing the admission formalities.**

All such candidates who have got a seat at NITK Surathkal through CSAB Rounds 1 and II , will be sent the login details for the admission portal of NITK through the email id registered in the CSAB portal after Special Round II reporting of CSAB-2020 . The

candidates who have secured their seat after JoSAA Round 6 at NITK Surathkal can complete the admission process during **26<sup>th</sup> November 2020-1<sup>st</sup>December 2020 if they have not done so during 16<sup>th</sup> -21<sup>st</sup> November 2020 using the login credentials already sent to them.** The online Admission portal of the Institute will be made live from November 25, 2020 (Wednesday) to fill-up the Online Admission form after the payment of the balance Institute fee.

Candidates are advised to fill their details through the NITK IRIS portal by logging in, at the MIS link <https://iris.nitk.ac.in/admission/admissions/login> and upload the documents listed below after payment of the balance Institute fee at the IRIS portal for admission at the institute. The details of fee to be paid are given below. The online document verification by NITK officials will be carried out during 26 November 2020 - 1<sup>st</sup> December 2020 and Provisional Admission Orders will be issued to the candidates online after verification.

4. Admit Card of JEE (Main)
5. Photo ID proof as per Govt. of India norms (Copy of Aadhar Card is compulsory)
6. Original Certificate of Date of Birth issued by competent authority/Class X (High School) Board Certificate as proof of date of birth
7. Original Mark sheet of Class XII
8. Medical Certificate in the format provided.
9. Original Certificate of category (OBC-NCL/SC/ST), if applicable, as per Government of India, issued by the competent authority. In case of OBC category, the certificate must be issued on or after April 1, 2020
10. Original Income and Assets Certificate for EWS candidates, if applicable, as per Government of India, issued by the competent authority. The certificate must be issued on or after April 1, 2020.
11. Original Certificate for Persons with Disabilities (PWD), if applicable, issued by the competent authority.
12. Undertaking to be submitted by PWD candidate in the format provided
13. Original Migration certificate of last institute/university attended
14. Original Conduct Certificate from head of the institution last attended
15. Original Transfer certificate from the head of the institution last attended
16. 16. Passport size photograph.

(If any certificate is in language other than Hindi or English or Kannada, translation of the same in English is to be produced with certification by the competent authority)

An additional amount of Rs.2000/- will be collected by NITK Surathkal from the candidates who had withdrawn/ cancelled after document verification in JoSAA Rounds and got allotted a seat in CSAB special Rounds , at a later stage, as they have remitted only Rs.71000/- to JoSAA/CSAB.

**Hostel Facility**

**Important Note:**

- (1) Candidates belonging to OBC –NCL or EWS category are required to submit the certificates in the prescribed format available in the NITK website (i.e. [www.nitk.ac.in](http://www.nitk.ac.in)) and issued on or after April 1, 2020.
- (2) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate in the format available in the NITK website (i.e. [www.nitk.ac.in](http://www.nitk.ac.in)).
- (3) The candidates who belong to PWD category must submit the certificate issued from a competent authority in the prescribed format available in the NITK website (i.e. [www.nitk.ac.in](http://www.nitk.ac.in)). The certificate which is other than the prescribed format will not be accepted. They also need to submit an undertaking along with the certificate. The prescribed format for the undertaking may be downloaded from the NITK website.
