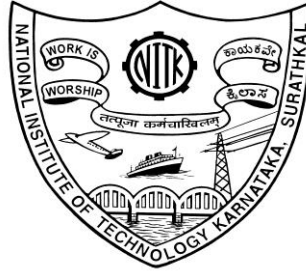

SECTION 1 A:- PROCEDURE FOR SUBMISSION OF E-TENDER

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. Below mentioned instructions are meant to guide the bidders for registration on the e-Wizard Portal, prepare their bids in accordance with the requirements and submit their bids online on the e-Wizard Portal. For more information bidders may visit the e-Wizard Portal <https://mhrd.euniwizarde.com>

1. REGISTRATION PROCESS ON ONLINE PORTAL

1. Bidders to enroll on the e-Procurement module of the portal <https://mhrd.euniwizarde.com> by clicking on the link "Bidder Enrolment" as per portal norms.
2. The bidders to choose a unique username and assign a password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the e-Wizard Portal.
3. Bidders to register upon enrolment their valid Digital Signature Certificate (DSC: Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile.
4. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse. Foreign bidders are advised to refer "DSC details for Foreign Bidders" for Digital Signature requirements on the portal.
5. Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.

2. TENDER DOCUMENTS SEARCH

1. Various built-in options are available in the e-Wizard Portal which is further synchronizing with CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters include Tender ID, organization, location, date, value, etc.
2. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, a form of contract, location, date, other keywords, etc. to search for a tender published on the Online Portal.
3. Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would

enable the Online Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.

4. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

3. BID PREPARATION

1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.
3. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that needs to be submitted. Any deviations from these may lead to rejection of the bid.
4. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF / XLS / PNG, etc. formats. Bid documents may be scanned with 100 dpi with black and white option.

4. BID SUBMISSION

1. Bidder to log into the site well in advance for bid submission so that he/she uploads the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
2. The bidder to digitally sign and upload the required bid documents one by one as indicated in the tender document.
3. Bidder to select the payment option as "Online" to pay the tender fee/ EMD wherever applicable and enter details of the instrument.
4. A standard BoQ format has been provided with the tender document to be filled by all the bidders. Bidders to note that they should necessarily submit their financial bids in the prescribed format and no other format is acceptable.
5. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, the opening of bids, etc. The bidders should follow this time during bid submission.

6. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data, which cannot be viewed by unauthorized persons until the time of bid opening.
7. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
8. Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

2. The tenders will be received online through portal <https://mhrd.euniwizarde.com>. In the Technical Bids, the bidders are required to upload all the documents in .pdf format.

3. Possession of Valid Class II/III Digital Signature Certificate (DSC) in the form of smart card/ e-Token in the company's name is a prerequisite for registration and participating in the bid submission activities through <https://mhrd.euniwizarde.com>. 7. **The item to be used is strictly according to the specification and subject to test by the Institute/concerned authorities. It must be delivered and installed in good working condition.**
8. The Institute **reserves the right to cancel or reduce the quantity** included in the schedule of requirements at any time after acceptance of the tender with a notice. The Contractor/Supplier shall have no claim to any payment of compensation or otherwise whatsoever, on account of any profit or advantage which he might have derived from the execution of the work/supply in full but he did not derive in consequence of the foreclosure of the whole or part of the works.
9. **Performance Security of 5 % of the contract value in terms of Bank Guarantee by scheduled banks shall be given by the successful bidder for the total period of Warranty. In the case of import, Indian Agent has to submit a performance guarantee in INR.**
10. **The release of EMD:** The EMD shall be released after receipt of performance security from the successful bidder.

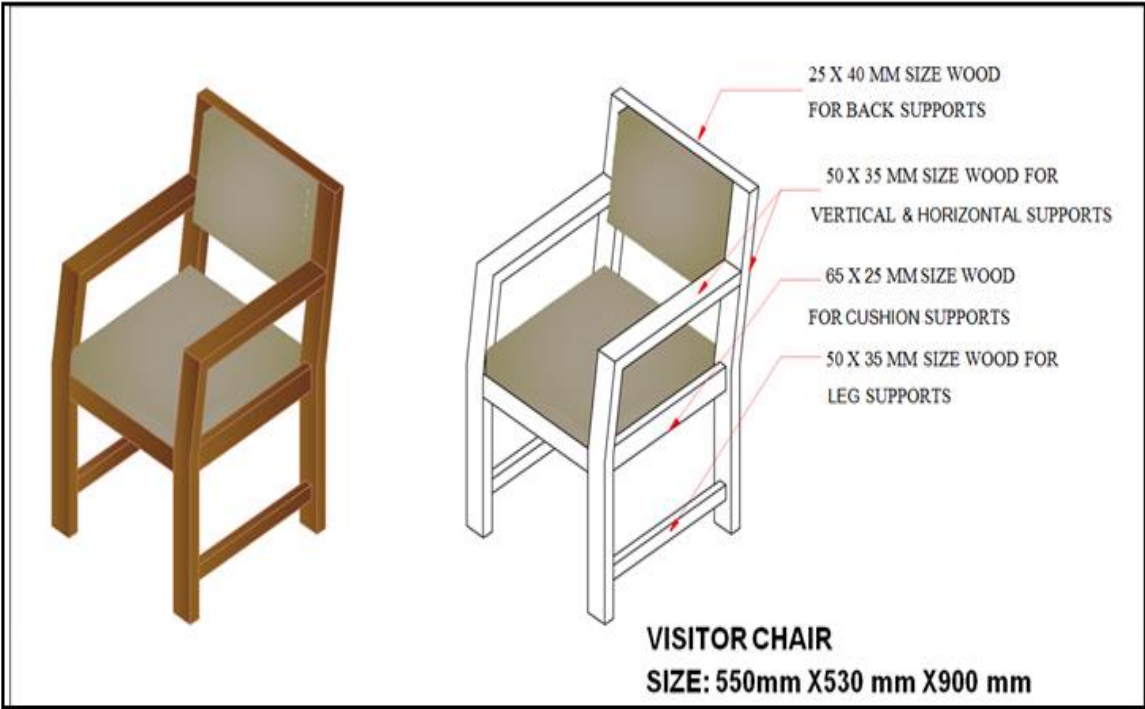
Detailed Technical Specifications

(1) Wooden Chairs with Cushion seat :

Manufacturing, Supplying and Placing in position Wooden Armed Chair with Cushion seat and back rest made by using Wild jack wood of size 50 x 35mm size for vertical, horizontal and leg supports, 65 x 25mm size for cushion supports and 25 x 40mm size for Back supports. The wooden surfaces should be treated with PU sealer mixed with PU Thinner and finished with 2 coats of P U Polish over 2 coats of polyurethane Interior grade sealer using polyurethane thinner to provide Anti-scratch and anti-stain properties (second coat of polish to be applied after drying of first coat) of M R F or Equivalent make and approved colour to give good finish. The seat and back rest should be fixed with 12mm plywood and covered with 50 mm thick 32 density moulded rubber with fabric cover for seat and 40mm thick 28 density moulded rubber with fabric cover for back rest. The work should be completed as per direction of Engineer-in-charge.

(2) Lab Chairs (Revolving) :

Supply of revolving Chair with backrest made up of 12mm thick (7 layers) hot pressed plywood and moulded back foam upholstered with fabric. Back rest size 480mm (H) x 475mm (W) .The seat is made up of 12mm thick (7 layer) hot pressed plywood and moulded seat foam upholster with fabric /leatherette. Seat size 470mmx (W) x480mm (D).the arm rest made up of injection moulded from block polypropylene. Arm rest Size 290mm (L) x60mm (W).Mechanism made out of MS plate thickness is 3mm and seat tilting angle is 20 degree. Also with the Seat tension adjustment knob. Gas lift pipe diameter 50mm and has a height adjustment stoke of 120mm.



(3) Office Tables :

Supplying of Office table made by using Boiling Waterproof marine quality conforming to IS 710 Green / Arched plywood sheets of Phenol bond with 15mm thick for all the external sides - doors cabinet sides, drawer and sliding keyboard and 25 mm thick for tabletop, as shown in the figure (DWG No.2). All the external surface of the table should be laminated with (Greenlam / sunmica) approved color, 1 mm thick and 0.8 mm thick for all internal sides. The exposed edges of the table should be finished with 2mm thick PVC edge banding of approved make quality and colour. The lamination and edge banding work should be done in Mechanical means with Automatic Roll, pneumatic press, heat and fix with approved adhesive for lamination and Automatic Gluing, Pneumatic pressure press, fine milling the edges, corner rounding, scrapping and buffing for finishing the edges for PVC edge banding. All the fixtures and fitting like hinges with screw for cabinet door shutter, SS Handle with locking arrangements, fiber bush, etc., should be provided of approved quality and make.
