2. The GST registration number, CPWD / MESCOM license copy, certificate and the PAN number of the bidder shall be enclosed along with the quotation. Quotation without this information will not be accepted.
3. Quotation may be dropped in the Tender Box kept in the office or may be sent by post/ courier. It is the responsibility of the bidder to make sure that the quotation is delivered in time. The quotations received after the due date will not be entertained.
4. The payment shall be made part bill basis and billing will be done on the basis as per the recommendation of the Engineer – in – charge. No interest will be paid for delayed payments if any.
